2. Separation of printing for 1099 NEC and 1099 MISC

- a. Each type of 1099 requires a SEPARATE 1096 form
- b. So we separated printing of 1099 MISC and NEC so that they aren't accidentally printed with the same 1096 form
- c. This change was accomplished through the MARK BY TYPE option in the 1099
 - i. To mark a vendor by type use the drop down to select the '1099 Type' and Select 'Mark'


